

## 2019 NEW JERSEY AIR QUALITY INDEX (AQI) EXCEEDANCE DAYS

*Updated 7/31/2019*

The AIR QUALITY INDEX (AQI) is a national index for rating daily air quality.

The higher the AQI value, the greater the level of air pollution and health concern.

An AQI value of 100 corresponds to the National Ambient Air Quality Standard (NAAQS) for a specific pollutant. For more information on the NAAQS see <https://www.epa.gov/criteria-air-pollutants/naaqs-table>.
